

# UNITED NATIONS PEACEKEEPING OPERATIONS CONTINGENT COMMANDERS COURSE

The Institute for Security Governance (ISG) United Nations (UN) Peacekeeping Operations Contingent Commanders (PKOCC) course prepares participants to take on the roles and responsibilities of contingent, battalion, and sector commanders in complex peacekeeping operations (PKO) for the United Nations and other multinational organizations.

### **OBJECTIVES**

Upon completion of this course, participants will be able to:

- Understand the operational environments of today's conflicts and commanders' roles in integrated missions.
- Understand the responsibilities and roles of effective command leadership of PKO personnel.
- Have an awareness and understanding of the various components of PKO.
- Understand the underpinning legal framework of UN PKO.
- ♦ Apply basic principles of negotiation and mediation.
- Understand the UN Women, Peace, and Security agenda; Protection of Civilians; and Counter Trafficking in Persons topics.

## **TOPICS**

The course methodology includes presentations from subject matter experts, group and plenary discussions, and classroom exercises. Group discussions and exercises focus on problem solving fictitious PKO scenarios and standalone problems related to various aspects of peace operations. Course topics may include:

- UN PKO and the Integrated Mission Planning Process
- Human rights
- Conflict management

- Negotiations and mediation
- The UN system, various field agencies, and operational coordination among them
- ♦ Force Command Mentor topics

## **PARTICIPANTS**

This course is ideally suited for mid- to senior-level officers worldwide and in all armed services, and for civilian government employees involved in relevant areas. Previous peacekeeping experience is desirable but not required.
