## **Functional Area Description**

The SCO functional area is focused on security cooperation (SC) operations conducted by a U.S. Military Group assigned overseas. This functional area prepares the SCO professional to liaise with partner nations on issues related to SC and DoD-administered security assistance (SA) to advance U.S. strategic objectives. The SCO functional expert track is for military and civilian personnel assigned to SCO positions who advise on matters related to the host nation and SC/SA activities, serve on the embassy country team, oversee facilitation of the full range of SC/SA execution in country, manage office resources, and lead SCO personnel.

# How will this better prepare you for your work?

SCO experts working at U.S. embassies will be able to apply their knowledge of the strategic and operational SC/SA environment to competently navigate the complex, dynamic environments within which they are expected to perform their assigned duties, thereby enhancing the overall efficiency and effectiveness of the SCO. Through SCO functional area certification training and education, the SCO expert gains expertise in their SC/SA role by working through real-world problems and critical tasks, applying skills through practical exercises, and elevating their critical thinking skills through research and analysis.
